- Interview people that can offer insight (i.e. Student Financial Advisers, Guidance Counsellors, Financial industry personnel); incorporate the advice into your submission.
- <u>Do not</u> give specifics on a person, school or geographic area. Any mentions in the submission are to be generic (i.e. banker, my university, my city). The required identifying information is to be provided on the Application Entry form.

2019-2020 Rules and Regulations

Credit Counselling Services of Atlantic Canada, Inc. (CCSAC) is holding a scholarship competition open to residents of Atlantic Canada (regardless of age) who will be enrolled in an accredited post-secondary program for the 2019-2020 academic year. Applications are accepted in both French and English.

- 1. The applicant must intend to enroll in an accredited institution for the 2019-2020 academic years. The winning applicants will be required to provide proof of acceptance and enrollment.
- 2. The submission must be the applicant's original work.
- 3. Submissions must be computer-generated on white paper-
- 4. The applicant's name, address, location or other identifying information MUST NOT be included in the essay. Identifying information should only appear on the application entry form.
- 5. Identifying information on those who are interviewed MUST NOT be included in the submission. In the essay include the title of the person you spoke with (e.g. your teacher, your banker) and the area of advice that they gave you. In the essay do not include their name and do not include information that will indicate geographic region (i.e. instead of principal of Sackville High, just state principal). Identifying information must only appear on the application entry form.
- 6. Materials must be postmarked, regular delivery, no later than April 12, 2019. Mail received after the deadline may not be accepted.
- 7. Do not contact the judges concerning this competition. Blind judging will be done on regional levels. Do not contact the scholarship chairperson beyond asking for clarification of the rules. Such contact may disqualify you from the competition.
- 8. Previous recipients of the CCSAC Scholarship, employees and board members of CCSAC and their families are not eligible for this contest.

Only submissions that conform to the rules and guidelines will be considered. Submissions cannot be returned and may be posted on the CCSAC website and/or used by the CCSAC Education department. Winners will be notified by the end of June 2019 and scholarship funds will be disbursed after January 31, 2020. *No materials other than the case study and application form are to be submitted.* The decision of the judges is final.

If awarded, <u>proof of enrolment in the 2019-2020 academic year **must** be provided by December 2019</u> to receive the scholarship amount. Failure to do so will result in the scholarship **not** being awarded.
