will default their awards.

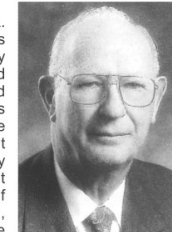
## OTHER AWARDS

No winner will be permitted to hold another MAJOR scholarship at the same time. Of course students are free to accept small bursaries, prizes, and offers of assistance from family. The Foundation has taken this stance because it believes that, despite its efforts by launching these awards, there are still too few scholarships to meet the needs of so many highly qualified applicants.



The late HUGH H. MACKAY was Vice-President of Maritime Beverages Limited and served on its Board of Directors and those of its progenitor companies for nearly 30 years. He saw overseas service in the Army during World War II and attained the rank of Major before returning to Canada in 1946. On his return to civilian life, he joined the firm of Pitfield Mackay where he was a Director for many years. He was also a Director of Great Pacific Industries Limited, and until its merger with Genstar was a Director of Canada Permanent Trust Company. Mr. Mackay was also a former President of Ducks Unlimited Canada and continued to take an active interest in the affairs of Ducks Unlimited as a Maritime Director until the time of his death. Known affectionately as "Yip", his presence is missed by many people.

The Late JAMES A. MacMURRAY, LL.D., was Chairman of MacMurray Foundation Inc., and had a long and distinguished business career. Among his diverse business interests he was Co-founder, President and Chairman of Fundy Cablevision Ltd. in Saint John, NB, President of Eastern Securities Co. Ltd., Chairman of Maritime Beverages Ltd., a Director of Bank of Canada, Bruncor Inc., New Brunswick Telephone Co., Brunswick Mining and Smelting Co., Empire Co., Sobey Stores Ltd., as well as a number of other Maritime-based companies. He was actively involved in many charitable organizations and was Chairman of Jeux Canada Games Foundation, a Director of Loch Lomond Villa Foundation, together with other community endeavours. In recognition of his achievements and service to the community, he was named a Member of the Order of Canada. He was awarded honorary Doctor of Laws Degrees by the University of New Brunswick and Mount Allison University, and was appointed a Laureate of the New Brunswick Business Hall of Fame.

The HUGH H. MACKAY - JAMES A. MACMURRAY scholarships are open to residents of the Province of New Brunswick who will graduate from high school in May/June of the year of application and who intend to enroll in a New Brunswick, Nova Scotia or Prince Edward Island University in the fall of the same year.

Scholarships will be awarded, each with a minimum value of \$5,000.00 per year, for each of the four years of the student's degree programme.

**CRITERIA**

Each candidate must:

- be a high school graduate in the year of application;
- be domiciled in New Brunswick;
- be an exceptional student;
- be interested in preparing for a career in business;
- complete the Official Application Form;
- submit a letter indicating personal career aspirations. Attached should be lists of activities including summer and part-time work, as well as other extra-curricular activities in which the applicant has been involved;
- ensure the school principal completes and submits the Principal's Confidential Report Form and a copy of high school records to date.
- begin studies in the Fall of the year of application in a New Brunswick, Nova Scotia or Prince Edward Island University.

**PAYMENT**

MacMurray Foundation Inc. ("the Foundation") will forward to the business office of the universities chosen by the winners, cheques in the amount of the scholarship, to be credited to the tuition account of each winner. If a balance remains, this will be given to the student early in the second term to assist in meeting other incidental expenses. If a student withdraws at any time during the year, the University involved will return any balance to the Foundation.

**Note:** No award will be confirmed until the Foundation has received, from the student, a photostatic copy of the OFFICIAL LETTER of Registration from the chosen university. It is not necessary to send the ORIGINAL letter of acceptance.

**RENEWALS**

Students who receive the Hugh H. Mackay - James A. MacMurray scholarships may, at the end of each undergraduate academic year, apply for renewal of the awards. This will require the submission of a personal letter in which they present progress reports on their studies. They must, in addition, ensure that the Registrar's Office sends to the Secretary of the Mackay - MacMurray Scholarship Fund copies of the official academic transcripts. Satisfactory progress towards the degree will assure renewal. Scholarships may be held for a maximum of 4 years.
